# Funding better local infrastructure: have your say on rate increase options

Ku-ring-gai Council is facing significant financial challenges to renew and upgrade essential local infrastructure in line with community expectations.

Over the past decade, the cost of providing Council services has increased by 40%, but the amount of money collected through rates has only grown by 28%. This gap is largely due to NSW Government rate pegging, which limits how much revenue councils can collect from rates each year.

In addition, Ku-ring-gai's total rates revenue per capita is below the Sydney average, despite Council having a large infrastructure portfolio to maintain.

This is reducing Council's capacity to maintain, renew and upgrade \$1.8 billion worth of local infrastructure, including buildings, stormwater and drainage, parks and recreational facilities, footpaths, roads and more. This infrastructure has been deteriorating for generations due to inadequate funding.

If this situation continues, the quality of infrastructure will continue to decline, with Council required to spend increasing amounts on temporary repairs. At the same time, independent research tells us that there is strong support for high-quality local infrastructure.

As a result, Council is seeking your feedback on four options:

- Base case Deteriorating Infrastructure (an assumed 3% increase in rates in line with the NSW Government rate peg)
- Renew Infrastructure (22% increase in rates, including an assumed 3% rate peg)
- Renew and Enhance Infrastructure (29% increase in rates, including an assumed 3% rate peg)
- Renew, Enhance and Expand Infrastructure (33% increase in rates, including an assumed 3% rate peg).
